Kemmerer Village Alumni Giving Back

If you have found your calling working with young people who have endured extreme hardships and hurt in their childhood, seeing them overcome and return to share their story is beyond rewarding. This past December, we had the opportunity to hear from two former Kemmerer Village youth.

Two former residents returned to campus. Dorothea "Dee" Moss Busby spoke to a large group of Kemmerer Village staff and children. She shared with them her hardships as a child and teenager before arriving at Kemmerer Village in the 1980's. She spoke about how the Kemmerer staff helped her find her self-worth and how to trust others. Today Dee has a bachelor's degree and is busy working as a substance abuse counselor, dedicated to her work and to the people she is working with. Our young people and staff listened intently as she talked encouraging them to use what they learn at Kemmerer Village. She reiterated **"that the tools you learn here today will guide you through the rest of your life."**



Our second homecoming was another former resident from the 1980's, Patricia (Patti) Liptay Cloe. Patti has stayed close through social media with a few of the staff at Kemmerer. She has just finished her bachelor's degree in nursing and plans to continue her education. Through her association with R & R Contracting at ADM, this group of employees has made a very generous donation to Kemmerer Village. During her visit Patti toured the campus and checked in with some of the staff still here. She also took the time to fill out the Village's volunteer application and plans to volunteer with the Equine Therapy Program and Horses and Hero's.

We would like to thank Dorothea and Patti for staying connected with Kemmerer Village and their desire to give back to a place that made a difference in their young lives.

Every Child's Needs are Unique

Even after a century of caring for children, there are still new and unique situations requiring cooperation and problem solving in groundbreaking ways. The story of Beth is a true testament of people going above and beyond. Beth was progressing through her treatment at Kemmerer Village, when she had yet another hurdle thrown into her path. Beth had a serious medical condition that required more specialized treatment than our staff could handle. Sending Beth to a hospital would have hindered

her significant mental health and educational gains for which she had worked so hard. Sending Beth home was not an option. This difficult situation became a paramount blessing in Beth's life. A local foster family stepped up to the plate in a huge way.

Craig Reed, a Mt. Zion Police Officer and wife Becky who works for Central A&M School are wonderful foster parents for two children through Kemmerer Village Community Service. Craig and Becky are also trained EMT's

and were able to offer the help that Beth needed. Beth stayed with the Reed family for almost 3 months, and they were able to care for her unique needs. This has become a great network of support for Beth. She continues to see the family twice a week when they take her to church with them at First Christian Church in Assumption. Beth even went to spend Christmas with the family this year. When people can put the needs of a child first everyone succeeds.

The Need For Sleep

Did you know that 1 in 5 children live in poverty in the US, and many of these families cannot afford beds? Children are the highest age-based population in poverty in the US. Twenty-two percent of kids in America live below the poverty line—the highest percentage among developed countries. Child poverty affects children's nutrition, self-perception, behavior, and more. But, with sleep being one of the most important things that humans do, **bed poverty, perhaps, takes one of the biggest tolls on poor children.** (Statistics from the National Center for Children in Poverty)

Your donations to Kemmerer Village help us provide for close to 200 children on any given day. Some of these children live on our 70-acre campus, while others are working on making a home with a caring family. Some of those families are willing to accept a child in need into their homes but they require help. When we need to place a child quickly there is no time for the family to get all the supplies to welcome another person into their home. **The biggest need in this situation is consistently twin-size beds.** Please contact us if you have a bed you are willing to donate or if you are willing to contribute to the cost of a bed for a child in need.

A life forever changed

Together we have helped countless children and improved an unimaginable number of lives. Kemmerer Village cannot thank you enough for this partnership that continues to help so many children. Today I want to brag on just one of these youth! Jason came to Kemmerer Village when he was 15 years old. He couldn't even tell you how many homes he had before that. If you could name something horrible that happened to a child, it happened to Jason. Jason persevered through human trafficking and numerous hardships of a childhood full of trauma, abuse and neglect.

Jason became an angry child prone to acting out, which led him to Kemmerer Village. When Jason arrived, he was quiet and bitter.

His face screamed that he wanted to be anywhere but here. Nothing seemed to impress Jason, until he met



Raven. Raven isn't just any girl, she is a gorgeous, kind and incredible therapist... she's also a horse. From the first experience Jason had with Raven and our equine therapist he was hooked. Jason began showing improvements in all areas of life so that he could earn more time at our stables. Jason brought up all his grades and became like a different kid. His time learning to connect with Raven taught him how to connect with others. He began opening up to staff and having giant successes in therapy. Jason told me that these early steps were all to gain more time with the horses. This behavior took hold though, and Jason reached the coveted phase 5 (meaning he was doing his very best.) Jason got up early and worked at the horse barn every morning and still managed to exceed at school. Jason encouraged the other children and motivated them. Jason found an incredible amount of self-pride volunteering for our community therapeutic riding program. He was such a star on campus it was bittersweet to see him move on to the next chapter of his life. Time passes as it always does, and two years later, I'm so excited to tell you about this email we recently received. Jason graduated from high school and is working and living on his own. He remembered us telling him that some generous people have donated to help kids of Kemmerer continue their education. Jason was enrolled in college, and I'm so thrilled that Kemmerer is able to help him continue to better himself. This is all because people like you are willing to invest in children like Jason.

Where There's a Will, There's a Way

Many of our friends would like to make a gift to Kemmerer Village but feel they cannot, for one reason or another. Perhaps you are reluctant to give away assets that you fear you may yet need, for your family or yourself. You may be afraid that a financial emergency could crop up, a disability, uninsured illness or a disastrous investment. These are all reasonable concerns for anyone exercising responsible stewardship.

However, there is one type of gift that almost anyone can make without jeopardizing financial security and that is a charitable bequest, in your will. In fact your bequest can provide a gift to Kemmerer Village that includes paying a life income to a loved one, thereby insuring that you can fulfill your commitments to both your faith and your family.

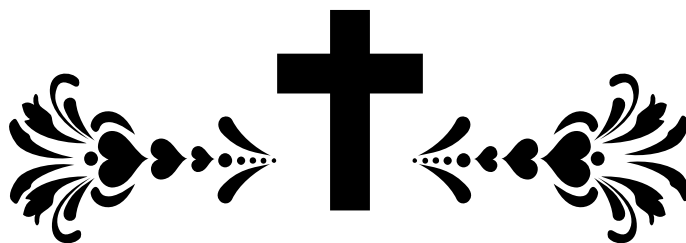
